- 1.2 The Meeting will be run in compliance with the FIA International Sporting Code (and its appendices), the provisions of the MSA General Regulations which comply with FIA Regulations, these Supplementary Regulations and the Championship Regulations of the individual series or championships listed in 2.7. All timings will be confirmed in final instructions and other instructions or information issued by the organisers.

- 2.7 All support races are organised in accordance with their specific Sporting & Technical Regulations.
- 2.8 Number of starters permitted:

GP3: 54
Porsche: 58
- 2.9 Entries will be in accordance with series/championship regulations.
- 2.10 Entry fees and passes issued will be in accordance with specific Championship Regulations and/or individual agreements with Allsport Management SA/Silverstone Circuits Limited. All personnel and vehicle passes will identify the team to which they are issued, and are issued on the condition that they are strictly not for resale. All passes remain the property of Silverstone Circuits Limited/Allsport Management SA and must be returned unless in use for genuine team personnel.
- 2.11 Times for administrative checks, scrutineering and qualifying/races will be in accordance with the timetable and other information issued by the organisers.

- 2.1 The 2017 FORMULA I ROLEX BRITISH GRAND PRIX will be held at:

- 2.2 Date of event: from Friday 14th July until Sunday 16th July 2017.
- 2.3 The status of the event is International.
- 2.4 The event will be run on the Silverstone Grand Prix Circuit.

Lap: 5.9 kms (3.666 miles).
Width: 12 metres
Clockwise direction
The pit exit is after Turn One
- 2.5 Insurance: The MSA (ASN) affects a Master Insurance Policy in respect of third party public liability risks to a level of £67,000,000 for any one accident.
- 2.6 Support races at the 2017 FORMULA I ROLEX BRITISH GRAND PRIX are:

FIA Formula 2 Championship
GP3 Series
Porsche Mobil 1 Supercup
- 2.12 All races are International therefore International licences relevant to the Championship regulations required (Article 2.2 ISC).
- 2.13 Classification will be in accordance with series/championship regulations.
- 2.14 Awards will be in accordance with series/championship regulations.
- 2.15 Failure to comply with the above will be considered a breach of these Regulations and the conditions of admission of the landowner. Only vehicles with the relevant passes will be admitted access to the infield.
- 2.16 Entrants or their accredited representatives will be responsible for all persons concerned with their entry complying with these regulations.
- 2.17 Entrants and Drivers must be present at scrutineering and sign the necessary indemnities at documentation.
- 2.18 Drivers must wear safety equipment (crash helmet, overalls etc) as specified in the Code during all practice sessions and races until the cars reach the Parc Fermé or their paddock location. These items must be available for scrutineering with the car.
- ARTICLE 3 – CONDUCT**
- 3.1 Flag signals will be given in accordance with Appendix H, Article 2.4 of the Code. Flag signals may be supplemented by lights.
